Minutes:

This Executive Council Meeting was called to order at 1:50 PM CST May 31, 2024 at Arkansas Technical University in Rothwell Hall with the President being in the chair and the Secretary present.

The previous meeting minutes were emailed prior to the meeting to be read. President Scarlet Hudgins asked if there were any corrections. It was brought up that the emailed minutes were a script therefore, Jack Cassell, the Secretary, read the minutes from the last meeting and they were approved. Kaleb Cotton, the Treasurer reported \$275,429.93 in the account. He noted that bills from the State Conference had not yet been charged to the account.

There was no old business brought up.

For new Business, Brody Ray, the District III State Vice President moved “that we accept all goals produced by the Arkansas Future Business Leaders of America officer team at the State Officer Leadership Academy” The motion was seconded by Kaleb Cotton, the Treasurer. With no debate it passed 17-0
